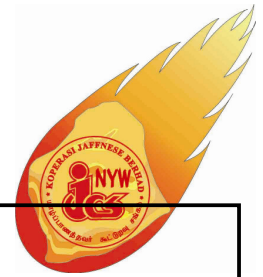

RULES & REGULATIONS

- 1 Participating vehicles shall be motorised and travel on 4 wheels (excluding lorries and buses) having valid road tax and insurance as at the day of the Hunt.
- 2 Each team shall consist of a driver and navigator, with an option of no more than 2 additional passengers.
- 3 The Driver in each team must possess driving licences valid as at the day of the Hunt.
- 4 All team members must sign the Declaration and submit it together with the Entry Form. The Declaration must be signed by parents / guardians on behalf of team members who are minors. The Driver and Navigator shall obtain the consent of the parents/guardians of all team members who are minors and the Organiser shall not be required to enquire if such consent has been obtained or not.
- 5 Entry Form is to be submitted in accordance with the instructions given in the Information Sheet issued in connection with this Hunt.
- 6 Proof of posting of Entry Form is not proof of receipt thereof.
- 7 Any change to the Entry Form after submission is at the discretion of the Organiser. No changes will be accepted or permitted after Briefing day.
- 8 At least 1 team member from each team must attend the Registration and Briefing and he /she / they shall be responsible for disseminating all information provided at Briefing to all other team members.
- 9 Starting order for the Hunt shall be as determined by the Organiser.
- 10 Competition numbers and various car stickers provided by the Organiser shall be placed on participating vehicles as directed by the Organiser and must remain on the vehicles throughout the Hunt. No other form of advertising other than those provided by the Organiser shall be permitted. All participants are required to wear the treasure hunt t-shirt should there be one provided.
- 11 All treasures submitted in the Hunt shall be given to a charity organisation, The organisation will be determined by JCS NYW Organisers and disclosed at a later date. No participants shall have any claim thereto.
- 12 The team that scores the highest number of points in the Hunt less penalty points incurred will be declared the winner and all subsequent positions will be determined on the same basis. Tie-breakers in the event of a tie shall be as announced to the participants at the Briefing.
- 13 The Organiser reserves the right without assigning any reason therefore to:-
 - (a) abandon, cancel or postpone the Event as deemed necessary;
 - (b) reject any Entry whether before or after the acceptance thereof;
 - (c) bar or exclude any one or more members from any team;
 - (d) disqualify and/or impose penalty points on any team found to have been guilty of
 - (i) the breach of these Rules and Regulations and road traffic rules
 - (ii) collaboration or cheating in any manner
 - (iii) providing a false Declaration and
 - (iv) failing to complete the Hunt within stipulated time.
- 14 These Rules and Regulations may be added to or amended at the discretion of the Organiser. These Rules, all additions and amendments thereto, and the interpretation thereof and the decision of the Organiser in all matters concerning the Event shall be final and binding on all participants.
- 15 Trip meter must be functional.
